## Kaohsiung Municipal Social Education Hall Fee Schedule of Site Usage

## Description:

1. For government institution and school, or non-profit educational cultural exchange organization, the site fee of which is discounted for 20% off.

- 2. Each session is considered to be three hours as a basic unit (less than three hours will be counted as three hours). If exceeding more than 15 minutes, another basic unit will be added.
- 3. Regular videotaping and recording serving only for news reporting will not be charged any fee. If recorded and produced by other institution, the charged is based on the fee schedule and should be filed with application procedure beforehand.
- 4. Activities approved by the municipal government for free site usage will not be charged for site usage fee.
- 5. Calculated monetary unit: New Taiwan "Dollar".
- 6. Activities approved for free site usage will only be exempted from site usage fee and will still be charged in accordance with the fee schedule for other fees.
